MN Challengers: Liability Waiver & Photo Release

MEMBERS AND GUESTS MUST COMPLETE THIS FORM.

A PARENT / LEGAL GUARDIAN'S SIGNATURE IS REQUIRED IF THE PARTICIPANT IS UNDER THE AGE OF 18.

In return for being allowed to participate in MN Challengers' activities, including any activities incidental to such participation (hereinafter "Organizational Activities"), the signee **Participant, or Parent/Legal Guardian of a minor Participant** (hereinafter referred as "I", "me", or "my") releases and agrees not to sue MN Challengers or its Officers, Directors, Members, employees, sub-contractors, sponsors, agents, and/or volunteers (collectively "MN Challengers") from all present and future claims that may be made by me, my family, estate, heirs, or assigns for property damage, sickness, personal injury, or wrongful death arising as a result of my participation in the Organizational Activities wherever, whenever, or however the same may occur.

I hereby freely and voluntarily, without duress, execute this Waiver under the following terms:

Waiver and Release. I, the Participant, understand that participation in the Organizational Activities involves certain risks, including, but not limited to, serious injury and death. I am voluntarily participating in the Organizational Activities with knowledge of the danger involved and I agree to accept all risks of participation. I release and forever discharge and hold harmless MN Challengers and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from my participation with MN Challengers and its events.

Insurance. I, the Participant, understand that I expressly waive any such claim for compensation or liability on the part of MN Challengers beyond what may be offered freely by the representatives of MN Challengers in the event of such injury or medical expense. I also acknowledge that MN Challengers has not arranged and does not carry insurance of any kind for my automobile or other personal property, Participant, or that of my Participant's parents, children, friends, guests, guardians, trustees, heirs, executors, administrators, successors and assigns. I represent that, to my knowledge, I am in good health and suffer no physical impairment that would or should prevent my participation in Organizational Activities. I also represent that, to my knowledge, I have (a minimum) state-required insurance coverage for my Dodge Challenger and all other personal property used during MN Challenger events.

Medical Treatment. I hereby release and forever discharge MN Challengers from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with MN Challengers.

Assumption of the Risk. I understood that my time with MN Challengers may include activities that may be hazardous to me, including but not limited to, driving automobiles at high speeds, construction activities, and loading and unloading of heavy equipment and materials. I hereby expressly and specifically assume the risk of injury and harm in these activities and release MN Challengers from all liability for injury, illness, death, or property damage resulting from the activities of my time with MN Challengers. I also agree to indemnify and hold harmless MN Challengers for all claims arising out of my participation in the Organizational Activities.

Other. I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the State of Minnesota in the United State of America, and that this Waiver shall be governed by and interpreted in accordance with the laws of the State of Minnesota. I agree that in the event that any clause or provision of this Waiver shall be held to be invalid by any court of competent, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable. I also understand that this document is a contract which grants certain rights to and eliminates the liability of MN Challengers.

Photographic Release. I grant irrevocably and absolutely to use MN Challengers all right, title and interest in any and all photographs, video or audio recordings of me or including my image or voice whether original or altered in any way (collectively "Photographs"), that are made by MN Challengers during my Organizational Activities with MN Challengers, including but not limited to, the right to use the Photographs for any purpose whatsoever in any form and to any royalties, proceeds or other benefits derived from them.
